



Proposal for IAU Field Judges course

by IAU Moravia World Cup in Plumlov in June 2024

The course for new Field Judges applicants and reaccreditation of actual FJ's and IJ's will be held on the meeting room of Football Stadion Sokol, Plumlov, Czech Republic. The course will be covered by IAU Moravia World Cup 2024 event.

Theoretical explanation of rules and guidelines on June 21st 2024 between 13:00 to 19:00 hour. Practical part on June 22nd 2024 on shooting field during the first day of IAU World Cup event. The applicants will be work as FJ's during the competition. Written test and discussion for new IAU FJ applicants between 17:00 to 19:00 hour.

The basis for IAU Field Judges courses is the **IAU Judges guideline** and the actual valid **IAU Field crossbow shooting rules for 2024**. The objective is to ensure that applicants for IAU Field Judges licenses have a proper understanding of the Rules, and their application, in respect of the events for which they seek to be licensed as Field judges.

The course will be conduct with Mr. Pavel Kaszonyi, IAU International Field Judge and instructor, accredited by IAU Field division technical committee in English language.

Every participant must be given a [registration form](#) to be filled in with his name, address and date of birth minimum 14 days before the course to the IAU Headquarter. The participant must indicate his experience and any special knowledge he has acquired during competitions in which he acted as a national Judge, and the qualifications obtained in his National Federation.

Participants who complete the course satisfactorily will be issued with an IAU Field Judge Diploma. The IAU Field Judge Diploma does not guarantee the issue of an IAU Field Judge's license; it only certifies the satisfactory completion of the official course. Official recognition of IAU Field Judges courses will be decided by the Chairman of IAU Technical committee and the Chairman of the IAU Judges Committee.

IAU Filed Judge License and IAU International Judge License shall be accredited maximum for four (4) years and the license holder have to send EUR 20 to IAU Headquarter account for the four years period.

The course organizer and OC of IAU World Cup is ready to cooperate in providing accommodation, meals and local transportation for the duration of the event.

The participation Fee for IAU Judge Course EUR 70,00 must be sent to the IAU account: Based on the Agreement IAI-PGSD Zagreb concluded on 28.3.2024.
