Report by Pero Stojnic, President of the IAU

Report of the IAU Executive Committee in the four years between the two original assemblies from 28.8.2021 to 7.9.2025.

Throughout this period, the members of the Executive Board participated in the board's work through 11 sessions, most of which were held electronically via the Zoom application. Numerous decisions were also made through electronic communication, all of which were made unanimously.

Throughout this period, the members of the EC IAU produced about thirty significant documents, which were missing in the normal functioning of the IAU. Thus, the previous mandate (2017-2021) continued, making it likely that, in the entire history of the IAU, so many documents regulating numerous aspects of the IAU's functioning have not been produced.

Period when he wasn't a member of the EC IAU

Members of the Technical Committees for Field and Match held several of their sessions, mainly in the periods of holding major world competitions such as WCH, ECH, WC and WCF. The main topic of their sessions was the improvement of the rules and the introduction of new disciplines. Every year, at the beginning of January, a new version of the IAU Rules for both Field and Match disciplines is published.

The registration of competitors was successfully organised through the issuance of ID numbers, and to date, a total of 439 competitors from 22 countries have been registered.

The Disciplinary Commission did not need to hold its session during this period.

It is especially worth noting that the COVID-19 crisis and the non-organisation of competitions in 2020 and 2021 left their mark on the development of the IAU. The number of competitors dropped rapidly. The ban on Russian athletes from competing in 2022 also contributed to this.

It is worth noting that the ECH and WCH were not held in the Match disciplines during this entire period. We believe in a better tomorrow because the following 2026 Field and Match ECH will be held in Chateauroux, France.

A special problem in the work appeared on 1.4.2024. when the IAU lost its account in Switzerland because it is not a registered organisation with the Swiss administrative bodies, and the fact that no member of the EC IAU is a Swiss citizen was mentioned in this context.

This situation was temporarily bridged with the help of the Croatian club, PGSD Zagreb, which specialises in crossbow shooting disciplines, and provided its bank account for use. A mutual agreement regulates this.

All members of the EC IAU were actively involved in seeking a positive solution to this problem, but without success. In early June 2025, a reputable law firm from Croatia, "Anić i Partneri", was hired to help us solve this problem in cooperation with its partners from Switzerland.

On March 12, 2025, the long-time IAU Chief Financial Officer and a great friend of crossbow sport, dear Josef Beckmann, passed away. Josef, thank you for everything.

At the session on April 6, 2025, EC IAU members appointed Tom Hafen of Switzerland to the position of IAU Chief Financial Officer.
