Regulations

On IAU Ambassadors

1. General Provisions

- 1.1. In order to further popularize the "Crossbow Shooting" sport, public and sports activities of the International Crossbow Shooting (IAU), the IAU Executive Committee by its decision forms the IAU Ambassadors' Cabinet Council.
- 1.2. Management of the IAU Ambassadors' activities shall be entrusted by the decision of the IAU President to one of the IAU Vice Presidents.
- 1.3. The IAU Ambassadors shall be appointed by the IAU Executive Committee's decision upon the recommendations of the national federations. In particular cases, the IAU Ambassadors may be appointed directly by the IAU Executive Committee's decision without any limitation on the term of powers - for life.
 - 1.3.1. Termination of powers is possible in cases involving a serious illness impeding the performance of the duties of the IAU Ambassador, in connection with death; in cases of discredit the high title of the IAU Ambassador, as well as in the event of a loss of communication with the IAU – by the decision of the IAU Executive Committee.
- 1.4. According to their status, the Ambassadors shall be divided into two groups:
 - the IAU Goodwill Ambassadors;
 - the IAU Athletes-Ambassadors.

2. Rights and obligations of the IAU Ambassadors

2.1. The IAU Goodwill Ambassador:

2.1.1. The IAU Goodwill Ambassador shall be appointed by the IAU Executive Committee's decision from among the persons who have a distinguished reputation among the IAU members, who have good experience in organizing work and who deserve well in international sports activities.

2.1.2. The IAU Goodwill Ambassador shall have the right:

- to represent the IAU interests in the territory of all world continents and states within these continents;
- to carry out international propaganda activities for the purpose of expanding the number of the IAU members;
- to conduct awareness-raising work to describe the IAU activities in the global development of crossbow shooting;
- to take part on the IAU delegations and individually in international negotiations in respect of the IAU activities;
- to participate in holding festivals, seminars, master classes and other events, within the framework of the IAU international programs;
- to prepare and post materials on the IAU activities in the media;
- to participate in press conferences, briefings, round tables focused on discussions on issues related to the IAU activities;
- to prepare proposals for consideration at the sessions of the Executive Committee related to the direct activities of the Ambassadors;
- to submit applications to the IAU Executive Committee on the encouragement of persons who are actively involved in the IAU programs' implementation.

2.1.3. The IAU Goodwill Ambassador shall:

- know the organizational structure and the main provisions of the IAU statute, the rules of the sport, the rules on competitions and other documents regulating the activity of the IAU;
- promote a general narrative meant to develop the IAU throughout the world, aimed at further development of the IAU and the sport;
- unconditionally implement all decisions of the IAU governing bodies and to competently follow them in his/her activities;
- use all available opportunities to popularize the IAU, to propagandize crossbow shooting and healthy lifestyle;
- be an absolute follower of the IAU's ideas for the purity in sport, for the conduct of an honest, uncompromising contest and fair refereeing;

- actively combat with any manifestations of the use of doping in sport;
- be a model of compliance with the rules and regulations of sports life;
- avoid actions that could harm the IAU and the world movement for the development of sport and crossbow shooting.

2.2 The IAU Athlete-Ambassador

2.2.1 The IAU Athlete-Ambassador shall be appointed by the IAU Executive Committee's decision from the athletes engaged in crossbow shooting, who have high achievements in world championships and deserved authority among athletes and coaches.

2.2.2 The IAU Athlete-Ambassador shall have the right:

- to represent the IAU interests in all competitions he/she participates, or is invited as a guest;
- to take part in international sports festivals, exhibitions, seminars, master classes and other sports and sports and mass participation events in order to popularize crossbow shooting;
- to advertise and promote crossbow shooting among athletes and coaches;
- to promote, in every possible way, the development of children's and youth sports in the framework of the IAU development programs;
- to attend events on the IAU delegations;
- to actively participate in the development of the material and technical basis of national federations;
- to act as an adviser to the heads of national federations in the development of crossbow shooting and the implementation of IAU programs;
- to submit proposals to the IAU Executive Committee on IAU's statutory activities and conduct of competitions;
- to take part in the development of amendments and additions to the Completion Rules;
- to speak in the media with materials describing the IAU activities.

2.2.3 The IAU Athlete-Ambassador shall:

- be a model of compliance with the rules and regulations of sports life;
- strictly comply with all internal corporate requirements and decisions of the IAU governing bodies;

- know and unconditionally fulfill sports rules, norms of behavior at competitions and in everyday life;
- set the example of high rectitude and morality, live a healthy lifestyle;
- make active efforts to root out corruption in sport, nationalistic manifestations, racial discrimination, as well as any manifestations of the use of doping in sport;
- actively advocate the IAU activities, promote, in every possible way, the popularization of crossbow shooting globally;
- actively participate in the work on involving new countries in the development of crossbow shooting under the auspices of the IAU;
- assist the national federations in improving the material basis and the training process in their countries.
