1. Adoption of the Agenda

Mr. Stojnic presented the agenda, which was approved unanimously.

2. Adoptions of the decisions taken at the IAU EC meeting, via Zoom application online videocall, on April 30, 2022

Mr. Vrbek presented the Minutes of the IAU EC meeting held on April 30, 2022 and all members of the IAU EC approved the Minutes.

This agenda was approved unanimously.

3. IAU Calendar 2022

Mr. Stojnic pointed out that at the previous IAU EC meeting all members agreed that there will be no IAU WCH neither IAU WCF in 2022.

Since the last meeting, Hungary volunteered to hold the IAU WCH in Field division, Croatia volunteered to hold the IAU WCF in Field division and Switzerland volunteered to hold the WCH in Match division.

3.1. IAU WCH in Match division

Mr. König, who was invited to a meeting as a guest, pointed out that he intended to organize a WCH in Match division, but unfortunately, he couldn't find enough support in Switzerland to organize this championship in such a short period of time. Mr. Stojnic thanked him and Mr. Brüsweiler for their effort.

The members of the IAU EC unanimously accepted this decision.

3.2. IAU WCH in Field division

Dr. Lenart, who was invited to a meeting as a guest, expressed her wish to organize a WCH in Hungary. She managed to find a support from the Government and Hungarian shooting federation, venue, shooting range, but she will also need a help from the IAU, specially with judges. A new date for the IAU WCH 2022 is 12-19 of August, 2022.

A place of the WCH will be Hungarian University of Agriculture and Life Science. This University has all the necessary facilities: shooting field, accommodation, restaurants, pharmacy, shops, etc. A price for room with two beds is 60 EUR and for the single bedroom is 70 EUR.

Mr. Stojnic thanked Agota for her desire and huge effort to organize a WCH in such a short period of time.

The members of the IAU EC unanimously accepted that the IAU WCH for Field division will be held in Hungary.

3.3. WCF in Field division

Mr. Pereglin, who was invited to a meeting as a guest, expressed his wish to organize a WCF in Field division in Croatia. A date for the IAU WCF 2022 will be 8-11 of December. The place will be the same as three years ago: a sports hall in Dubrava. In two weeks, he will have a few important meetings in Croatia and after them, he could confirm this organization.

The members of the IAU EC unanimously accepted that the IAU WCF in Field division will be held in Croatia.

Mr. Stojnic concluded that there will no be a WCH for Match division this year, that WCH for Field division will be held in Hungary and WCF for Field division will be held in Croatia.

4. Discussion about the IAU Member Federations voting about the status of the Crossbow Shooting Federation of Russia and its athletes

During the online voting round via e-mail from 2 till 6 of May, 2022, the IAU Member Federation had to choose one option their federation considers correct:

1. No sanction or decision is needed on the status of the Crossbow Shooting Federation of Russia and its athletes
2. The IAU should forbid Russian athletes to use national flag and anthem
3. The IAU should forbid Russian athletes to take part in the IAU events.

There were 3 votes for the option 1, 2 votes for the option 2 and 11 votes for the option 3.

The members of the IAU EC approved the option with the most votes: The IAU should forbid Russian athletes to take part in the IAU events. This decision is valid from May 7, 2022.

In the context of this decision, the IAU EC accepted a proposal of the IAU President Mr. Stojnic that Mrs. Shishorina continue to serve as the IAU Vice President for Asia.

This Agenda was unanimously approved.

5. Financial information

Mr. Beckamann presented the financial documents. One document the Invoice from KRÜGER-BONUS 2021 (2022/901). The BONUS 448,35 EUR is paid on 29 April, 2022, on the IAU-Account.

The other document is with the list for the IAU Membership fees with payment on 30 April, 2022. Sweden payed a membership fee 2021 (2021/029) on 26 of January, 2022. Netherland payed a membership fee 2021 (2021/022 on 14 of April, 2022.

This Agenda was approved unanimously.

6. Other undefined issues

6.1. India in the IAU

Mr. Stojnic mentioned that India is no longer a Member Federation of the IAU, because they didn't pay a membership fees in 2 year. In India there are three crossbow federations which are familiar to the IAU. Mrs. Shishorina has a task to contact all Indian federations and negotiate with all of them about entering the IAU, because only one federation from one country can be a part of the IAU.

6.2. Medals for the IAU WCH, CCH, WC, WCF

The IAU office found a medal producer in Croatia and in the following few days, the IAU office will have a final pricelist for the medals. Ordering medals is very urgently, because WC in Innsbruck is very soon. The IAU office will inform the members of the IAU EC as soon as they got an information about the prices.

Mr. Stojnic thanked everyone for their time and he specially thanked to Dr. Lenart and Mr. Peregrin for their effort to hold the IAU championships in such a short period of time. He also thanked to Mr. König for his wish, and they agreed that Switzerland should organize a WCH in 2023.
